Developed by the ministry of Culture of the republic of uzbekistan, which implies the following mass-cultural event and concert calendar year of watching the formulation of plans and approval of the regulations on the procedure for approval:

- mass-cultural event and concert watching a holistic system of achievement and participate in the organization and conduct of the form;
- mass-cultural event and concert calendar, watching the formation and approval of the plan;
- financing activities implied in the calendar plan.

Calendar plan accordingly the cabinet of ministers, the council of ministers of the republic of karakalpakstan, the region, tashkent city, district and city administration, as well as the decision was

Concert-watching activities of state bodies and the implementation of all services of the organization by individuals on the basis of the contract is formed according to the orders in written form is shown to pay in exchange for a fee, concert-watching activities stemming from the implementation of the labor contract with employees of the institutions of the state, with the exception of mujburiyatlar made. Calendar measures within the framework of the funds allocated to this purpose implied in the plan of the republic of uzbekistan karakalpakstan republic, republic of the budget and budget, the region, tashkent city, district, city and local budget funds at the expense of the customer funds, as well as other sources not prohibited is financed at the expense of legislative acts.[2]

The cabinet of ministers 2021-23 year-in February “Mass-cultural and concert-calendar year plans formulation and watching the event on approval of the procedure of approval” approved by the resolution dated 98 on the regulations in the territory of the republic of uzbekistan on international and national levels, as well as from foreign countries of the republic of uzbekistan tomom watching the concert on the organization and conduct of the event and the mass media calendar year determines the order of formation and confirmation of plans.

**The following mass-annual cultural and entertainment events and concert calendar, the new year of plans and the main functions of the form:**

- the organization of the event and participate in the conduct of achievement form a holistic system;
- the organization of the event and conduct targeted and efficient use of budget funds to be transferred;
- clear information on the organization and conduct of the event in advance by the media and the general public get the opportunity to create five;
- artists who are attracted to the event by state bodies and organizations in written form, the contract is formed according to the order of all services in exchange for payment to show on the basis of the structure is introduced.
- **the customer** – who have expressed a desire to interested state bodies and organizations of the event;
- **executive** – event organizational, artistic, or physical parts of the implementation of the official contract on the basis of the legal person;
- **mass-cultural and watching the concert event (events)** – a national holiday in a traditional way, which held the state in the event of the artistic parts of the professional holiday, the date of whose outstanding namoyondasi anniversary, the opening and closing ceremonies of the event and other international sports events, festivals, contests, and concerts, folk festivals, and other events. The measures approved in the annual calendar plan of the republic of uzbekistan ministry of culture and the ministry of culture of the republic of uzbekistan, regions and tashkent city are conducted in consultation with the department of culture.

Calendar plan of the republic of uzbekistan ministry of culture and the ministry of culture of the republic of uzbekistan, regions and tashkent city department of culture of the republic on the basis of the offer by the customer, of the republic of karakalpakstan, regions and tashkent city, district and on the scale of the city produces.

Republican state bodies and organizations of relevant offers on the event (the customer) by the ministry of culture, state bodies and regional organizations (the customer) by the ministry of culture of the republic of karakalpakstan, regions and tashkent city department of culture , together with the

following documents shall be submitted:

- basic documents on the organization and conduct of the event;
- the concept of the event;
- the estimate of costs and funding projects approved by the customer of the event.

The ministry of culture of the republic of uzbekistan ministry of culture and offers, regions and tashkent city in full compliance with all requirements provided by the department in the case of culture is accepted.

***Calendar plan is the following:***

**the calendar plan of the republic** – the state bodies and other organizations in the country (the customer) shall be formed by the ministry of culture on offer and is approved by the decree of the cabinet of ministers;

**calendar of regional plans** regional state bodies and other organizations (customer) on the offer of the ministry of culture of the republic of karakalpakstan, regions and tashkent city department of culture of executive power shall be formed by the decision of the relevant local bodies and was approved by.

A holiday calendar to plan the event of the artistic parts of the state, the professional holiday, the date of whose outstanding namoyondasi anniversary, the opening and closing ceremonies of the event and other international sports events, festivals, contests, and concerts, folk festival and other events are included.

***In the period following the calendar every year and according to the plan shall be approved and shall be formed in the order of:***

- calendar list of events is included by the customer to plan formation during the month of march;
- included in the list of the calendar by the customer to plan the event by the relevant ministry or the ministry of culture the ministry of culture of the republic of karakalpakstan, regions and tashkent city department of culture of submission to – during the month of April;
- The ministry of culture and the ministry of culture of the republic of uzbekistan, regions and tashkent city department of culture of the plan by the synthesis of the list of input events calendar - during the month of April;
- The ministry of culture and the ministry of culture of the republic of uzbekistan, regions and tashkent city department of culture of the procedure that is specified by a list of events that add to the calendar plan executive authorities or local government for approval to the cabinet of ministers of the add – on per month up to June of each year;
- The cabinet of ministers and local authorities in the manner prescribed by the executive review and approval of the plan, calendar – during the month of October.

Calendar local executive power bodies approved the plan the ministry of culture and will be announced through official websites and other media.

The president of the republic of uzbekistan, the cabinet of ministers, bodies of executive power of the local plan, which refers to holding the event to the calendar this event is not included in the decision on the organization of the customer and the source of their funding is determined.

***Calendar the calendar plan of the republic and regional events implied in the plan:***

- Local budget funds of the republic of uzbekistan and the republic;

***Raja amendments and additions to the calendar can be in the following cases:***

- the date of the event and (or) the place when changed;
- when the need has arisen to add a calendar to plan additional events;
- when changes and additions to the artistic part of the event;
- the composition of participants of the event or when the number changes;
- when conditions change and the financial possibility of the customer;
- has allocated funds for the event.

The ministry of culture and the ministry of culture of the republic of uzbekistan, regions and tashkent city department of culture of executive or by local authorities in consultation with the cabinet of ministers accordingly, the calendar can be changes and additions to the plan.

This event is carried out at the expense of the customer which are necessary for the additional costs.
